DRAFT MINUTES of the MEETING of LEZANT PARISH COUNCIL held at TREBULLETT METHODIST CHURCH HALL on TUESDAY 11 JANUARY 2022 at 7:30PM.

(22.001) Declarations of Interest. No declarations of interest were made.

(22.002) Representations from the Public. No members of the public were in attendance.

(22.003) Cornwall Councillor's Report. Cllr Parsons sent his apologies. He was unable to attend due to a prior commitment with another parish council in the division. With regards to a report Cllr Parsons emailed that he had very little information or updates to offer this month as it had been very quiet over the Christmas period. He noted he would be particularly interested in Councillors thought's on the upcoming agenda item on the A388. The Chairman read out an additional email from Cllr Parsons, that had been circulated, regarding traffic issues on the A388 and a Transport Studies programme.

(22.004) Confirmation of the Minutes. The minutes of the meeting held on 14 December 2021 were approved by all present and signed by the Chairperson.

(22.005) Matters arising from the Previous Meeting (for report only):

Gritting the road at Wooda Bridge. An update was read out from CORMAC explaining the advised location was on the precautionary salting route, so would be gritted every time there was a weather warning for potentially low/freezing temperatures. In addition, the maintenance train had recently gone through the A388 so there shouldn't be any drainage issues at this location. The site was to be brought to the attention of the Highway Safety Inspector, who could monitor the location on the monthly driven inspection. CORMAC clarified that all salt bins had previously been removed from these precautionary routes as they were gritted - so the provision of a salt bin was no longer deemed necessary.

Junction markings at Trebullett. CORMAC had responded stating that the junction markings would be refreshed post April 22 once the new budget was in place.

(22.006) Playground Equipment & Maintenance – to agree any action and associated costs. The issue of damaged goal nets at Jubilee Field was discussed. It was proposed by Cllr Nash, seconded by Cllr Cairns and RESOLVED that the clerk purchase new nets for the goal posts at the Jubilee Field.

- a) An update from Cornwall Council on the pedestrian crossing at Treburley. Councillors were informed the Scheme Designer had made another site visit to confirm the extent of the carriageway widening on the east side and was in the process of completing the construction drawings and paperwork. All being well plans should be costed up and handed over to the construction team in January. The clerk had asked whether any of the measures raised at the site meeting in September 2021 had been incorporated and was waiting for a response.

- c) It was reported that the roadside hedges on land at Pengloss were in need of cutting back. It was proposed by Cllr Unwin, seconded by Cllr Simmons and **RESOLVED** that the clerk write to the land owner drawing their attention to the issue.
